Fleet Partners Novated Lease Protection may be ideal if you have the option of receiving a motor vehicle as part of your salary package.

What is Fleet Partners Novated Lease Protection?

Fleet Partners Novated Lease Protection is provided by an insurance policy issued to Fleet Partners. Subject to the terms of that policy, Fleet Partners Novated Lease Protection provides cover to eligible Fleet Partners lease customers who wish to receive the benefit of the cover provided to Fleet Partners.

If you become involuntarily unemployed, Fleet Partners Novated Lease Protection provides up to a maximum benefit of \$15,000 if you remain involuntarily unemployed for more than 30 days. Fleet Partners Novated Lease Protection may apply in one of two ways:

Option 1: Lease Repayment Cover

If you choose to keep the vehicle, lease payments will continue to be paid for a further 150 days or until the maximum benefit of \$15,000 is exhausted, whichever comes first. No excess applies.

Option 2: Hand Back Cover

If you return the leased vehicle to Fleet Partners within the first 30 days of becoming involuntarily unemployed, lease obligations are paid out up to the maximum benefit of \$15,000, subject to an excess of \$250.
